- * On December 3rd, I attended two trainings:
- 1- Using Schools as a Shelter
- 2- Gang Awareness Training
- * On December 5th Jason Hansiak, presented training on Therapeutic Holding Techniques and behavior management to 11 staff members. He will be returning this Wednesday to train 11 additional staff members.
- * On December 10th, I participated in a conference call with Congressman, Josh Gottheimer, superintendents form the Fifth Congressional District and representatives from the Federal Bureau of Investigations, Department of Homeland Security and the Anti-Defamation League to discuss steps schools can take to educate our students, respond to incidents and help put a stop to the rise in hate crimes.

*Sustainability Update:

Currently investigating incorporating a Green Fair for the Spring. Looking to coordinate with book fair, art fair and fit fair to run simultaneously.

Outdoor Air Quality Awareness bulletin board moved to West Wing hall. Hoping to organize student helpers to assist with reading the daily air quality and displaying the corresponding flag.

- * Regarding Erate reimbursement, we completed FY 2019 Form 470 & FY 2019 Client Furnished Information form.
- * We submitted our school breakfast improvement plan to the State of New Jersey.
- * Medical waiver payments and rebates were dispersed on December 14th. Projected annual medical waiver payments of \$75,798 (13 FTEs) compare to prior year medical waiver payments of \$81,892 (11 FTEs) resulting in a Y-O-Y decrease of \$6,094. Medical rebate amount was dispersed per the KTEA contract.
- * We completed our ASSA submission for the 18-19 SY. Our enrollment for submission was 174 students down slightly from 184 students a decrease of 5.4%.
